Invitation for Bids for the 11KVA Transmission Line, 100KVA Transformer and 400VLT Line Installation

1. The Government of Nepal has allocated funds towards the cost of **11KVA Transmission Line, 100KVA Transformer and 400VLT Line Installation** and intends to apply part of the funds to cover eligible payments under the Contract For 11KVA Transmission Line, 100KVA Transformer and 400VLT Line Installation (Works/NCB/074/075). Bidding is open to all eligible as per Section V of Bidding Document.
2. Dullu Municipality Office invites **online bids only under e procurement system** from eligible bidders for the 11KVA Transmission Line, 100KVA Transformer and 400VLT Line Installation under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **3 Crore (Without VAT)**
 - Minimum Work experience of similar size and nature: at least 2(Two) Contract within the last ten (10) Years, With the Value of at least NRs **2 Crore 40 Lakhs (Without VAT)** that Have Been successfully or are substantially completed.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

 5. Bidding document is available online and can be downloaded from e-GP system <http://www.bolpatra.gov.np/egp>. Interested bidder should register in the e-GP system and deposit the cost of bidding document NRs **5000 (Five Thousand)** in the following specified Bank.

7. Interested bidders should submit online bids through e-procurement portal <http://www.bolpatra.gov.np/egp> only on or before **12:00 hours on Aug 15 ,2018**. Bidders are required to follow the electronic bid submission procedure as specified in e- GP System Operating Guideline 2074 issued by PPMO which are available in e-GP system www.bolpatra.gov.np/egp
8. Online bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 on Aug 15, 2018** at the office specified above. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security amounting to a minimum of NRs **7,50,000 (Seven Lakhs Fifty Thousand Only)**, which shall be valid for minimum 30 days beyond the bid validity period the scanned copy of bid security in pdf format should be uploaded in the e-GP system during bid submission.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. All interested bidders are requested to consult PPMO or Dullu Municipality Office for the information about online bidding till date **Aug 9, 2018**.
11. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
