Bids received after this deadline will be rejected. The bids will be opened in the presence of Bidders' representatives who choose to attend at 25-02-2022 14:00 at the office of Dullu Municipality Office. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 210000.0, which shall be valid for 30 days beyond the validity period of the bid
